TERRITORY OF MISSOURI

(Established as Territory by Act of March 3, 1805, effective July 4, 1805. Territory reorganized by Act of June 4, 1812, effective December 7, 1812. Territory existed until Missouri admitted as State on August 10, 1821. Authority to appoint Marshals by Act of February 27, 1813.)
