



BID INVITATION

On May 30, 2012, the U.S. District Court, Northern District of Illinois, Western Division, issued a *Protective Order Directing the Interlocutory Sale of Certain Property in United States of America v. Rita A. Crundwell*, Case No. 12-CR-50027 (N.D. Ill. Filed May 1, 2012). The Order named one 2009 Liberty Coach Motorhome, model H3-45, D/S, VIN: 2PCV334988C711148, and directed its sale as a single unit by the U.S. Marshals Service (USMS).

The USMS is offering the following unit for sale "As Is, Where Is" and subject to the terms contained in the accompanying Sealed Bid Terms and Conditions for U.S. District Court Ordered Sale.
