DISTRICT OF SOUTH CAROLINA

(P.L. 9-242; Oct. 7, 1965; 79 Stat. 951; effective November 1, 1965, consolidated the two judicial districts of the State of South Carolina into a single judicial district. The Act provided that the two marshals then in office would continue in office until the President appoints a Marshal for the new single district.)
