Inauguration:

DC/DC continues to run point on the coordination for the Inauguration as is standard practice historically. IMT's plan is as previously outlined in the CONOPs to prepare to deploy but there has been no activation request at this time. I agree with recommendation that an assessment team from (0, (7)) would be warranted. I would suggest a minimum of one of you, a Plans, and Logs Chief to deploy to (b) (7) (E) in order to prepare for the full team deployment and activation of the JOC as needed.
