- ▶ 94 U.S. marshals, one for each federal court district
- ▶ 4,038 deputy U.S. marshals and criminal investigators
- ▶ 1,570 administrative employees and detention enforcement officers
- ▶ 5,608 total employees
- ▶ 94 districts, 218 sub-offices, four foreign field offices

Budget

- ▶ FY 2023: \$1.705 billion (salaries and expenses)
- ▶ FY 2022: \$1.496 billion (salaries and expenses)
